Julia Joy Beauty Co. offers mobile services providing exclusive makeup and hairstyling services for your wedding day by highly trained and qualified makeup and hairstyling experts. Also offering Airbrush Spray Tan, and Mobile Teeth Whitening.

Traditional makeup is applied by professional hand tools such as brushes and beauty blenders and can be worked into the skin for an even finish. The coverage of traditional makeup can range from a natural dewy glow to a matte heavy/full coverage based on the products used. We use professional, high quality, natural mineral-based long-wearing products such as Mirabella and SST Cosmetics. Some of our other brands include Charlotte Tilbury, Nars, Dior, Urban Decay, Too Faced, Elf and MAC.

Airbrush makeup is sprayed onto the skin using an airbrush machine instead of being applied with brushes and beauty blenders. The airbrush pressure can be adjusted to apply various types of makeup such as lighter, heavier, or more detailed styles. Our product is water-based and fragrant free, paraben free, and free of petroleum derived ingredients. The natural product is formulated for even the most sensitive skin types. Our airbrush foundation will give you a flawless no makeup natural look. Mineral based pigments have a softening effect on the skin, blurring any skin imperfections and fine lines. The highly pigmented formula means very little makeup is needed to get full coverage. It won't be shiny nor flat or dry looking - which is great for the camera!





For **hairstyling**, we use a variety of professional salon quality brands such as Aveda, Amika, Redken and Pai-Shau.

SunnaTan spray tan is an all-natural tanning formula that works with your skin to bring out your unique, natural pigments. We customize your tan to your specific skin type, tone and preference. Our technique and solution has been perfected to ensure a natural, even brown tan every time! Our Clear Quickie tan is a tan you can rinse off 1-5 hours after we tan you. This solution does not have any bronzer so you do not have to worry about getting anything on your clothing. You leave the same colour you arrived in and it develops over time. You **MUST** shower 5 hours later. This solution is formulated with hyaluronic acid and prickly pear extract.

SunnaSmile is an LED light activated teeth-whitening system. This advanced formula was designed to provide maximum oral health benefits white whitening. It's proven to be effective, enamel-safe, low-sensitivity, and a convenient option available for use at-home or "in-studio". The SunnaSmile gel absorbs the LED light energy, which photo-chemically "excites" the peroxide molecules into breaking down faster. It provides "activating energy" that speeds up and improves the performance of whitening. Terms & Conditions

COMMUNICATION: We appreciate prompt communication from our clients. If you request to move forward with your booking and received an agreement, your date will be held for 5 days. If we have not received a signed agreement and deposit within the 5 days, we have the right to release your date. If you have not heard from Julia Joy Beauty Co. within one (1) week of your scheduled appointment(s), please contact us immediately to confirm your appointment. Confirming appointments is a shared responsibility. To avoid miscommunication, Julia or Nadine must be the only contact point when discussing details of your appointments (not the service providers).

DEPOSIT | PAYMENT: The deposit is due on signing the agreement and is non-refundable. For Canadian residents, deposits may be paid by E-Transfer (julia@juliajoy.ca). For outside of Canada, deposits in \$CA may be made via PayPal where a payment link will be provided for you to make the payments. Please note there is a 5% processing fee added for all PayPal transactions. Please let us know if you will be paying your deposit/balance via PayPal. The final balance owing is due prior to the event date. We accept E-Transfer or PayPal. We ask that one person be responsible for the final payment. Please note, that your date is not secured until we receive both the signed agreement and deposit. When sending the deposit and or final balance, please make a note in the field: bride's first and last name and trial/ wedding date.

CANCELLATION | AGREEMENT CHANGES | OUTSTANDING BALANCES: The client agrees to pay all fees if 1) this agreement is cancelled six months or less before the event. 2) If services within your group have been cancelled six months or less before the event. Please only book the confirmed numbers at the time of booking your services. There is no deadline to add on services, however, we cannot guarantee that we will have availability. We do require a credit card number on file to secure your booking. If there is an outstanding balance after services have been provided, the credit card number given will be charged. Your credit card will only be charged if the cancellation policy applies or if there is an outstanding balance. Please note there is a 5% processing fee added for all credit card transactions.





UNCONTROLLABLE CIRCUMSTANCES: If your event needs to be postponed or if Julia Joy Beauty Co. is unable to provide the services due to an uncontrollable circumstance (ie: pandemic, natural disasters, delays, or failures in transportation (as well as extreme road conditions from inclement weather), etc.) you may reschedule for no extra charge. There is no refund on the deposit under any circumstances.

EVENT DAY TIME CHANGES: We will do everything we can to accommodate changes in your schedule. However, if changes are substantial, we may not be able to provide the same makeup artist/hairstylist and, in the worst case, the contract would be cancelled, and the cancellation policy would apply. Unless it is dangerous, weather conditions like rain or snow won't cause rescheduling.

MODEL RELEASE | SOCIAL MEDIA: The client hereby assigns Julia Joy Beauty Co. the right to use and publish photographs of the client on social media as part of the portfolio. We appreciate being mentioned (tagged) on social media. If either you or your photographer requires our information, @juliajoybeautyco is who provided the services (not the service provider's personal accounts). Proper crediting is extremely important since our work is regularly published.

TRIALS: Trials are recommended but not mandatory. If you have booked your trial with us or have yet to book your trial with us, the terms and conditions apply to trials. A deposit will be taken for your trial appointments. We are mobile and will come to you for your trials if you are located within Calgary and area, or we will come to your pre-arranged accommodation in Canmore/Banff. Please note - 1) Travel fees may be applied based on your available stylist/ artist. 2) Trials will only be accommodated Monday-Friday.

HAIR EXTENSION PLACEMENT: Please advise us well in advance if you or members of your group are considering clip-in hair extensions so that we can schedule the necessary time. It is the client's responsibility to provide the extensions. Please note that there is a placement fee of \$30+gst.

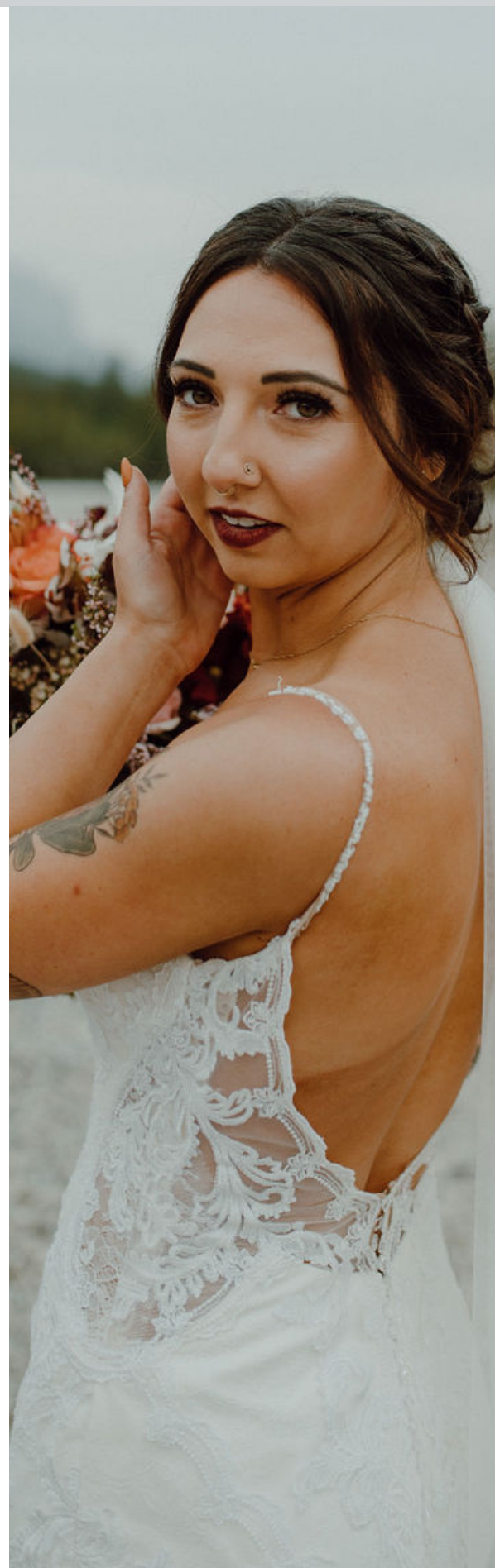
Terms & Conditions Continued

LIABILITY: All brushes, hair, and makeup products are kept sanitary. Most makeup products used are hypoallergenic. Any skin conditions or sensitivities should be reported by the client to the makeup artist prior to the event date. This includes any latex allergies as most lash glues contain latex. Extreme sensitive clients may prefer to use their own skincare and/or cosmetics to prevent complications. The client agrees not to hold Julia Joy Beauty Co. liable for any complications or adverse events that result from the makeup and/or hair application.

EXPECTATIONS: Our services are provided based on the information and/or inspiration photos you provide. Our service providers each have their own artistic style. We recommend familiarizing yourself with our portfolio to ensure you are comfortable with our style of work. If your preferred hairstyle, such as an updo, a half-up, Hollywood glam waves, curls, or blowout, is not suitable for the client's hair type, the stylist has the responsibility of communicating with the client alternative styles that will better suit the client's hair type. Julia Joy Beauty Co. is not liable for any problems resulting from unclear, erroneous, incomplete, misleading, or false information. If you or anyone else in your party is unsure whether a particular style will work for you, please send us a photo of your inspiration and your current hair so that we can give you advice.

ALLERGIES AND HYGIENE: Julia Joy Beauty Co. is not responsible for any reactions to makeup. If you or your bridal party are suffering from any type of contagious illness including, but not limited to, conjunctivitis, eye styes/cysts, cold sores, open wounds/cuts on the face and neck, staph infection, head lice, the flu or other contagious illness, we need to be informed as a matter of urgency and reserve the right to refuse service of any infectious person. This is a precaution taken to ensure non-contamination.

PRODUCTS AND TOUCH UPS: Anyone receiving services are responsible for their own touch-up products on the wedding day, including, but not limited to hairspray, lipstick, lip gloss, powder, blush, blotting sheets, etc. A stylist and or makeup artist can be scheduled for a fee, for pre- or post-ceremony touch-ups.





DAY OF: It is common for the bride to create a schedule for their group to follow. The schedule may include the names of everyone in the group, their services, and their designated service providers. Despite this being an organized method of direction, some services might take longer than others or may not be synchronized exactly as you'd like. While we recognize that the group is well organized, it would be better if it didn't follow any strict schedule, and instead, the group knew who would be doing the services first, and everyone else would know who they would be following rather than a time-based schedule. If a member of your party or guest would like to add a service on the day of the wedding, it will be at the sole discretion of the stylist/artist. These additional services must be paid in full to the provider. Please note that only cash will be accepted.

SERVICE LOCATION AND REQUIREMENTS: The location of services for the day of the event will be at the discretion of the client, however, there are certain requirements the artists need for accommodation. A "set up" work area needs to be made available for both the makeup artist and hairstylist at said location. Ample lighting, preferably using natural light (such as a window) or lamps is necessary for services to be performed properly. Please have counters cleared before arrival in designated areas. The stylist will need a low-back chair and the makeup artist will need a bar stool height chair (which can be requested at the front desk of the hotel if not already in the room) and access to electrical outlets. Stylists are responsible to provide their own extension cord. Artists are responsible to provide their own ring light.

Please make sure your face is clean and free of makeup. If receiving a hairstyle please make sure hair is washed and 100% dry from the night before your hairstyle, otherwise, a fee will be applied to drying time. Bring your headpiece, veil, hair extensions (a placement fee will be applied), and any hair accessories to your trial and the day of your wedding. Provide inspiration photos of different hairstyles and makeup looks that you are interested in for the artists to consider. Note: Pinterest is inspiration, not expectation. Pinterest pictures are often photoshopped and unrealistic in terms of colour accuracy and quality. We also ask that each person receiving a service be ready at the time of the stylist/artist's arrival time. This will ensure that no one is running late on either end.

REFUSAL OF SERVICES: If any of the hairstylists/artists feel uncomfortable, threatened, or verbally abused in any way, they will have the right to leave the premises without completing services.
